That said officers may arrest any individual who stands in the way or obstructs their rightful attempts to obtain the immediate custody of said child(ren) _____[child(ren)]; and That in the event the matter cannot be immediately heard by King County Superior Court, said child(ren) is/are placed into custody, said officers shall place the said child(ren), tacolo R. (-antine [child(ren)] into the care and custody of Department of Social and Health Services (DSHS~DCFS) until the first date the matter can be heard following the date of the recovery of the child(ren); and That the Department of Social & Health Services (DSHS~DCFS) shall place said child(ren), Tacob R. (Jantine [child(ren)] into Protective Custody upon the request of the said peace officers until such time as this matter may be heard in the Superior Court of Washington for King County.
