**Warrant in Aid of
Writ of Habeas Corpus**

The State of Washington, To: The **SHERIFF OF KING COUNTY** and each and every other peace officer in the State of Washington:

In the name of the State of Washington you are hereby authorized to break and enter any residence, building, structure, or vehicle in which you have reason to believe the child(ren), Jacob Gantive [child(ren)], is/are located or where information pertaining to the location of the child(ren) may be found, i.e., the residence of Michelle Watts [respondent] at Issaquah, Washington [address] in order to secure the custody of said child pursuant to the expressed order of this Court; and,

You are further ordered that in the event the said child(ren), Jacob Gantive [child(ren)], is/are not produced, Michelle Watts [respondent(s)] and any and all other persons who may stand in the way or obstruct your efforts to carry out the order of this Court shall then and there be apprehended and brought before the Unified Family Court Judge of the Superior Court of Washington in and for the County of King at the Regional Justice Center of said court at Kent, Washington, for questioning.

In the event that the King County Superior Court is not in session at the time of apprehension, you are commanded to hold Michelle Watts [respondent(s)]

or any other person standing in the way of producing the wanted child in the King County Correctional Facility until the first date court is in session following the date of apprehension.

In the event that the matter cannot be immediately heard by King County Superior Court at the time the child(ren) is/are placed into law enforcement custody, the King County Sheriff or any other peace officer in the State of Washington is hereby commanded to place the said child(ren), Jacobs Coartine [child(ren)], into the care and custody of the Department of Social & Health Services (DSHS-DCFS) until the first date court is in session following the date of recovery of the child(ren).

In the name of the State of Washington, pursuant to the above order, Department of Social & Health Services (DSHS-DCFS) is hereby commanded to take custody of said child(ren), Jacobs Coartine [child(ren)], and place the child(ren) into protective custody until such time as this matter may be heard in the Superior Court of Washington in and for the County of King. The child(ren) shall not be released to any person other than the King County Sheriff or any other peace officer in the State of Washington acting in accordance with this order; or, upon a Return of Service on this Writ of Habeas Corpus, and further order issued from the King County Superior Court authorizing the release of said child(ren) to a person designated by this court.
