MITTIMUS FOR CONTEMPT

This cause having come on for hearing on the return of a Rule to Show Cause, heretofore entered on 1/8/15 and the Respondent, MICHELLE WATTS, being present in open Court, and the Court having heard testimony and being fully advised in the premises FINDS:

1. That the Court has jurisdiction of the subject matter and the parties hereto.
2. That the Respondent was ordered to pay \$ COMPLY WITH REUNIFICATION PLAN & COOPERATE per Child Support commencing WITH DESIGNATED THERAPIST PER ORDERS DATED 4/20/15 & 8/17/15. The Respondent was further ordered to pay \$ \_\_\_\_\_ per \_\_\_\_\_ towards an arrearage of \$ \_\_\_\_\_. The Respondent has willfully refused to comply with this order, thereby causing an arrearage of \$ \_\_\_\_\_.
