**Order to Issue Writ of Habeas

**I. Basis**

A  petition  motion for a Writ of Habeas Corpus has been presented by Michael Gantine [moving party],  pro se  by and through his or her attorney, David H. Kalisek [attorney].

**II. Findings**

The Court has reviewed the records, files, affidavits, and heard argument, and deems itself fully advised.

**III. Order**

**It is Ordered:**

That a Writ of Habeas Corpus, and Warrant in Aid of, is issued directing the Sheriff of King County, Washington, or any other peace officer of the State of Washington to locate and take Jacob R. Gantine [child(ren)] into immediate custody and to deliver said child(ren) as soon as reasonably possible to the Unified Family Court Judge of the Superior Court of Washington in and for the County of King at the Regional Justice Center of said court at Kent, Washington; and

ORIGINAL

That said peace officers may break and enter any residence, building, structure, or vehicle in which they have reason to believe the person is located or where information pertaining to the location of the person may be found; and

That said officers may arrest any individual who stands in the way or obstructs their rightful attempts to obtain the immediate custody of said child(ren)

Jacob R. Gantine [child(ren)]; and

That in the event the matter cannot be immediately heard by King County Superior Court, said child(ren) is/are placed into custody, said officers shall place the said child(ren),

Jacob R. Gantine [child(ren)] into the care and custody of Department of Social and Health Services (DSHS-DCFS) until the first date the matter can be heard following the date of the recovery of the child(ren); and

That the Department of Social & Health Services (DSHS-DCFS) shall place said child(ren),

Jacob R. Gantine [child(ren)] into Protective Custody upon the request of the said peace officers until such time as this matter may be heard in the Superior Court of Washington for King County. Further, the child(ren) shall not be released to any person other than the King County Sheriff or any other peace officer in the State of Washington acting in accordance with this order; or, upon a Return of Service on this Writ of Habeas Corpus, and further order issued from the King County Superior Court authorizing the release of said child(ren) to a person designated by this Court.
